If a fee and/or documentation are required, attach to the application and mail to the address above. Once the completed application, including all supporting documents, is received it will be processed. An application requiring background investigation will require additional time to process. Incomplete applications will be returned unprocessed and result in a \$25.00 charge.

- There is not a fee for this application. Complete Section **A** before completing Section B and Section C.
- The former broker** completes and signs section **B** which releases the broker from the firm and updates the Commission record on their individual broker license. *If the broker is unavailable to sign, attach a copy of the minutes removing them from the position or a copy of their death certificate or obituary.*
- The new broker** completes and signs section **C**
- Attach supporting documentation, *if required*.
